Press Release

June 14, 2011

On Sunday, June 12, 2011 at 10:34 PM the Willoughby Police Department responded to the Travelodge Motel, 34600 Maplegrove Extension, for a reported fight between a male and a young girl. An officer arrived on scene and noticed several people standing in front of room 158.

The male, later identified as Bernard Corradetti, age 50, was observed throwing an item to the ground, shutting the door to room 158 and entering a 2004 Chevrolet Trailblazer. Corradetti was detained by the first responding officer.

Officers then identified three (3) females. The females were identified as a fifteen (15) year-old from Willoughby, a fifteen (15) year-old from Eastlake, and a thirteen (13) year-old from Wickliffe.

Officers learned from the girls that Corradetti had made arrangements through text messaging for a sexual encounter with two of the girls. Corradetti had known the girls for about one week. Corradetti picked the girls up at a Willoughby restaurant. He then went to a store and purchased alcohol. Corradetti dropped the girls off at another restaurant and left to go purchase marijuana. Corradetti returned with the marijuana and took the girls to the Travelodge Motel where he rented a room.

Inside the motel room Corradetti provided the girls alcohol and marijuana. At some point, Corradetti paid one of the girls one hundred (100) dollars and began discussing what sexual encounter would occur between him and the girls. After some time, the girls became frightened and attempted to leave without completing any sexual acts.

When the girls attempted to leave, Corradetti blocked the door and prevented them from leaving. Corradetti took one of the girl's cell phone in an attempt to recover his cash. When the girls tried to leave again, Corradetti began to assault the girl that he had earlier paid and the altercation ended up on the sidewalk outside of room 158.

Officers arrived shortly afterwards and detained Corradetti and the females.

Corradetti was charged with the following:

Three counts of compelling prostitution, a felony of the 3rd degree.

Three counts of abduction, a felony of the 3rd degree.

Three counts of corrupting another with drugs, a felony 4th degree.

One count of importuning, a felony of the 4th degree.

Corradetti was arraigned today and had a bond set by the Willoughby Municipal Court at \$250,000 cash or surety.

A preliminary hearing has been set for Thursday, June 23, 2011 at 1:00 PM.
